Foreword

Domestic abuse has a devastating effect on families, children and our local communities. It is an under-reported crime estimated that 1 in 20 adults experience domestic abuse every day, equating to 21,000 people a year across Buckinghamshire.

The Bucks Domestic Abuse Strategy 2021-2024 identified that tackling domestic abuse needed to go beyond providing domestic abuse support services, but instead embed an awareness across all services and staff to ensure effective prevention, identification and intervention. Training is key to this to ensure that multiagency staff feel confident to handle disclosures.

Victims and survivors engage daily with frontline professionals within our community. Whether it be a GP appointment, seeing the midwife, discussing housing options with the Housing Department or registering for housing benefit. It is the purpose of this training offer to ensure that professionals positively spot the signs of domestic abuse, and the victim/survivor feels listened to and offered support service options.

This multiagency training catalogue is aimed towards all key partners and agencies to understand the uniqueness and complexities of LGBT+ communities, minority ethnic groups, children and young people in order to foster a better understanding of how abuse may present. The training will cover the issues, barriers and best practice and ensure the highest quality engagement with victims and survivors.

Opportunities for a victim/survivor to disclose are few. In order to deliver a service that ensures Buckinghamshire residents feel able to safely disclose and receive help, multiagency staff need to continually develop their domestic abuse skillsets and apply the highest standards of professionalism and empathy. To achieve this, the Buckinghamshire Domestic Abuse Board requires buy in from the multiagency partnership to actively support and encourage their staff in attendance of this training.

Through the delivery of this training offer, it is hoped that more victims will be identified and helped at the earliest opportunity.

DA Act 2021 Power Hour

Virtual via MS Teams

We will move onto what attendees can do to help and what they should not do and where to signpost people to find appropriate support.

- Review the statutory guidance framework
- Appreciate the impact of these abuses
- Understand the mindset of those living in a distorted reality

- Consider what leads to discrimination and what the impact of it is
- Consider how to manage cases dealing with people who fall under protected characteristics
- Discuss what you can do to help & what not to do
- Identify specialist services that can support and advocate.

Challenges in Recognising Victims and Perpetrators Power Hour

It will also consider what trauma can do and factors to consider when counter allegations are being made and offer some tools to cut through to the truth of the matter.

- Consider how perpetrators may prevaricate as a victim
- Discuss how to help identify one from the other
- Sort misinformation from information
- Consider how to "perpetrator proof" your organisation

Children and Families

This event is funded by Buckinghamshire Council and is aimed at those working in that area.

Learning Aims & Objectives

- Understand why we now consider children living with DA, victims
- Compare the short- and long-term effects it has on children living with domestic abuse.
- Understand how domestic abuse can affect normal childhood development
- Understand how to manage cases as an agency and/or as a practitioner

Scenario Based Training- Making Sense of and Assessing Domestic Abuse

Face to Face training

Course Length- 2 consecutive days for each cohort **Cap-** 25 attendees per session

Training for early help staff only at this time. As a pre-requisite staff should have completed GCP2 training as this will be used in the session.

Description

Using scenarios and interactive training methods your learning and confidence will build over the two days to enable delegates to be more confident in engaging, empathising and productively working with those living with domestic abuse. *Small amount of role play will be required.*

Learning Aims & Objectives

- Understand prevalence of domestic abuse, typologies, and tactics.
- Have more insight into the impact on both the adult and child(ren) victim-survivor and the potential impact of this trauma on their relationship.
- Understand the challenges and practice ways of engaging with domestic abuse victims.
- Be able to define and describe the level of risk for both adult and child.
- Be confident in using a small number of standardised measures that can be used to bring clarity.
- Understand the areas of focus and where to start and order any work.

Adolescent to Parent Abuse

Virtual via MS Teams
Course Length- 3 hrs
Cap- 15 attendees per session

Description

An interactive, practical session introducing the themes of Child and Adolescent to Parent Violence and Abuse. It is designed to raise awareness of CAPVA and provide participants with an opportunity to explore the dynamics of the issue and strategies to support families. Information will be provided on definitions, background theories, prevalence, risk factors, case studies and behaviour patterns and an overview of models of work will be provided. The session aims to increase practitioner knowledge of this issue and explore ways to respond, give an example of an intervention and some useful activities for supporting both parents and young people.

This half-day (3hrs) course is suitable for all those who currently work with young people or families and wish to further their knowledge on CAPVA. It is suitable for both frontline practitioners and service managers including domestic abuse specialists, youth offending teams, social care & children's services, police, NHS, youth workers, parenting workers, educationalists etc.

Learning Aims & Objectives

- To gain an understanding of the dynamics and contexts of CAPVA
- To gain an overview of background theory, sector statistics and risk factors
- To understand the barriers and approaches for engaging families
- To look at key strategies in supporting families facing CAPVA
- To increase knowledge about current service provision and developing practice

MARAC/DASH

Face to Face Training

This course is suitable for professionals that need to complete the DASH Risk Assessment and also gives an overview of the MARAC process.

Learning Aims & Objectives

- Defining domestic abuse with an update on the DA Act 2021 and the changes to current practice/legislation
- Handling disclosures of domestic abuse and responding well
- How to introduce and use a DASH Risk Indictor Checklist (RIC)
- Understanding risk thresholds of the DASH and next steps
- Understanding MARAC and making referrals
- Practice completing initial safety planning and how to support the client to access specialist services

LGBTQ+ Awareness Outreach: Understanding Challenges & Domestic Abuse

Virtual via MS Teams
Course Length- 3.5 hrs
Cap- 40 attendees per session

Description

This session will enable you to develop your knowledge of sexual identity and gender. You'll be able to understand the barriers that LGBTQ+ face throughout their life, and how this intersects with the challenges of domestic abuse and mental health.

Learning Aims & Objectives

- Feel better equipped and able to facilitate discussion or understand gender and sexuality through:
 - Developing knowledge around terminology, language, and use of pronouns.
 - Exploring the difference between gender identity and sexuality
- Have an insight into the challenges and barriers people from the LGBTQ+ community face in their day-to-day life through:
 - Understanding what these barriers are in different areas of life
 - Hearing anecdotes and case studies to conceptualise what these barriers look like in everyday life
- Understand the nuance and specifics of how domestic violence is presented within the LGBTQ+ community
- Feel equipped and better able to support LGBTQ+ people

Understanding the Impact of Sexual Assault and Abuse

Face to Face Training

Course Length- 3 hrs

Cap- 15 attendees per session

Description

Working with trauma is significantly different from 'regular' therapeutic work. Being trauma-informed is having an understanding of the many different ways trauma impacts and changes our brain and nervous system. This training is for anybody who works with survivors of sexual abuse, assault and trauma. It will provide insight into what it is like to be traumatised and what it is survivors need to be able to cope. This training will help you to understand the impact of trauma on the brain and how certain symptoms develop as a means to survive threat, as well as understanding the prevalence of trauma in society and how we as professionals can support a survivor's journey to recovery.

Learning Aims & Objectives

- Understand the dynamics and prevalence of rape, sexual assault and abuse
- Understanding what triggers, the friend, flight, fight, freeze and flop responses and the impact on the brain during trauma
- Recognise the barriers faced by survivors and the coping strategies that they
 use
- Understand how we can work with survivors who have experienced trauma

Introduction to Female Genital Mutilation (FGM)

Virtual via MS Teams
Course Length- 2 hrs
Cap- 100 attendees per session

Description

The course will begin by examining the definition of FGM and the four types as identified by WHO. An update on the current global situation and emerging trends in FGM will be presented and this will be followed by a discussion of the situation in the UK. We will then explore the reasons for the continuation of the practice in the UK and the impact that FGM has on survivors. The second part of the course will outline the legal situation concerning FGM in the UK and the responsibilities of safeguarding professionals, including mandatory reporting. You will be introduced to the Petals for Professionals Webapp which is a one-stop resource aimed at helping safeguarding professionals deal with suspected cases of FGM or that somebody is at risk of being subjected to FGM.

Learning Aims & Objectives

At the end of the course, you should:

- Be aware of what FGM is, types of FGM, global patterns and emerging trends of FGM, as well as the situation in the UK.
- Have some understanding of the reasons for the continuation of FGM amongst FGM affected communities in the UK, including the social and cultural norms perpetuating the practice.
- Be cognisant of the impact of FGM on those subjected to the practice, including health consequences (physical and psychosocial and sexual) as well as human rights implications.
- Be familiar with your legal responsibilities concerning FGM, including mandatory reporting.

"Honour" Based Violence (incl Forced Marriage)

Course Length- 2 hrs

Description

This course will build your confidence in identifying and challenging "Honour" Based Abuse and Forced Marriage. It will build resilience when challenging issues of 'cultural sensitivity' and will outline the effective supportive responses for victims. The course will encourage critical thinking to challenge justifications of abuse on the basis of tradition, culture or religion and will demonstrate the development of victim pathways for safe and effective responses.

Learning Aims & Objectives

- Explain the support Karma Nirvana offer to victims, survivors and professionals
- Definitions of HBA and FM and the triggers for these abuses
- Dispel common misconceptions
- Offer an insight into understanding honour systems & honour codes within family dynamics
- Identify HBA and FM and explain the warning signs and indicators
- Clarify best practice when dealing with HBA and FM
- Provide an insight into FM law and FMPOs
- Explain the prevalence nationally and statistics for professionals
- Demonstrate how HBA and FM is happening in emerging communities.

No Recourse to Public Funds (NRPF)

Description

This session set out the information and support options available for people with No Recourses to Public Funds within the immigration Law and the European Union Settlement Scheme frameworks. It identifies the referral routes and signposting agencies available for a person at risk of domestic abuse when they are unable to access benefits and housing pathways.

- What the NRPF rule is and who this applies to
- How the NRPF rule affects entitlement to domestic abuse services and homelessness pathways
- Support organisations and best practice
